Treasurer’s Report – Dave Johnson was absent but the balance May 2 was \$68,000.

League Long Course Championships -

Time standards are the same as the past few years

Entry times may be from meets after July 1 of last year

A check or check request must be in the hands of the entry chairperson by the first day of the meet

Coaches were asked to download the meet information again so that the meet information would reflect the changes.

The executive committee has met and proposes the following changes for our **winter championships**

The League meets will be known as

SWOYSL South Sectional Championships

SWOYSL Central Sectional Championships

SWOYSL North Sectional Championships

SWOYSL Short Course Championships

SWOYSL Long course Championships

We may use times from March 1 of the previous year or the first day of sectional championships (whichever comes first)

Highland YMCA will compete at the south championships Announcers will be assigned as they add to the professionalism of the meet

A motion to accept the block of changes by Bill Whatley- second Toby Boedeker

Unanimous approval

The executive committee agreed that each sectional site would have limited flexibility in changing sessions for the sectional meet

Age of a swimmer for competition – YMCA National Swimming and Diving Committee has adopted a policy that the swimmers age the first day of the meet is the age for records and top 16. The executive committee proposed that the league adopt the same policy. After a great deal of discussion the question was called. The motion was voted down. The age up date for our league will remain as December 1.

Fall meeting – Date – We are attempting to get a date the week of September 17-20.

Records – Records can be set by a swimmer in meets outside our league as long as the swimmer is representing their YMCA.

Motion to set league records using swimmers age calculated on the first day of the meet.

Swimposium – bill Whatley reported on the Swimposium. Dates are October 5, 6, 7.
Information should be available in the next few days.

Officials Clinics – The program is changing. We will go back to Level I & II. Level I will now be stroke and turn. Level II will be starter and referee. For this reason we are not offering a new clinic this spring. We will have one recertification clinic May 31 at Countryside YMCA. Time 6:30 PM. We will offer more clinics in the fall and one trainer’s clinic.
